WHAT IS THE PRODUCT?

Type	Class C investment unit of the Fund.
Term	The term of the Fund's operations is linked to the term of Oaktree Power Opportunities Fund VII Feeder (Luxembourg), SCSp (the "Master Fund"). The Fund, like the Master Fund, will operate for a period of ten (10) years from the commencement date of the Master Fund's investment period, i.e. from 1 September 2025, unless this term is extended in accordance with the Master Fund's documents.
Objectives	The Fund seeks long-term appreciation of the capital invested by its Participants by collectively investing the accumulated capital into securities (units) issued by the Master Fund. The Master Fund invests in companies whose core business consists of providing key products and services to owners of critical infrastructure assets in North America and Europe, including electricity, natural gas, water, wastewater and other energy and utility-related businesses. These investments are intended to deliver an adequate risk-adjusted return to the Fund's investors. The Fund will invest at least 85% of its Net Asset Value in the securities issued by the Master Fund. The Fund's assets will not be directly diversified; sufficient diversification will be achieved at the level of the Master Fund through its investment policy and strategy as set out in its incorporation documents. Redemption of investment units is restricted. During the Fund's term, the units will not be redeemable at the request of investors. The Fund does not use a benchmark index. Amounts distributed by the Master Fund for the benefit of the Fund will not be reinvested, except where: (i) the Fund is required under its commitments to transfer such amounts to the Master Fund to cover its expenses; (ii) unrestricted funds of the Fund are proportionally distributed to investors; or (iii) the reuse of funds is necessary to ensure proper fulfilment of obligations of the Management Company or the Fund under applicable law or under the Master Fund's governing documents. The Fund may use leverage, i.e. it may borrow to increase the scale of its investments and potential returns. Borrowing may increase both potential gains and potential losses and therefore increases the Fund's investment risk. The Fund's leverage ratio does not exceed 150% under the gross method and 150% under the commitment method, as defined in Commission Delegated Regulation (EU) No 231/2013. This financial product promotes environmental or social characteristics, but does not have sustainable investment as its objective.
Intended investor	The Fund is intended exclusively for informed investors (as defined under the laws of the Republic of Lithuania) who can tolerate a particularly high level of investment risk and the potential losses associated with it. Investors must also be comfortable with long-term investment horizons. The minimum investment amount for this class of units is USD 2,500,000.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Risk	This is a high-risk product. This means that losses related to the Fund's future performance might be significant and it is highly likely that poor market conditions could affect the return on investments.

It shows how likely it is that you will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 6 out of 7, where 6 represents a high level of risk. The risk indicator assumes that you keep the product for 10 years. If the product is not held until the end of the recommended holding period, the level of risk may be significantly higher than shown by the summary risk indicator. As the Fund is denominated in US dollars (USD), your return may increase or decrease due to changes in the exchange rate between the euro and the US dollar. The actual risk can vary significantly if you exit earlier, and you may get back less. You cannot cash in before the end of the Fund's term. The units are not redeemable at the request of investors during the term of the Fund. Early exit is possible only by transferring the units to another investor, subject to the consent of the Management Company. There is no organised secondary market for the units, so you may not be able to sell your investment easily or at a price acceptable to you. This product does not provide any protection against future market performance, so you could lose some or all of your investment. PERFORMANCE SCENARIOS

The figures shown include all the costs of the product itself, but may not include all the costs that you pay to your advisor or distributor. The figures do not take into account your personal tax situation, which may also affect how much you get back.

What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The stress scenario shows what you might get back in extreme market circumstances.

The scenarios shown are illustrations of the possible outcomes under the stress, unfavourable, moderate and favourable scenarios, the projected returns of which – after the fees and costs of the Master Fund, but before all Fund-level fees – are –6%, 6%, 20% and 32% respectively. Most of the costs are incurred at the Master Fund level. The performance scenarios are based on expert judgement. The scenarios do not take into account the impact of currency fluctuations. The scenarios assume that the entire stated amount is invested at once.

It means that the average annual return is calculated without taking into account the actual timing of such distributions.

WHAT HAPPENS IF UAB INVL ASSET MANAGEMENT IS UNABLE TO PAY OUT?

The assets of the Fund are segregated from, and accounted for separately from, the assets of the Management Company. Therefore, investors in the Fund would not suffer any losses in the event of a default or insolvency of the Management Company. However, an investor may suffer financial losses if the Fund itself fails to meet its obligations. The Fund does not participate in any investment compensation or guarantee scheme, and the assets of the Fund are not insured under any deposit or investor guarantee system. As a result, you could lose your entire investment.

RECOMMENDED HOLDING PERIOD: 10 YEARS		
The Fund's units cannot be redeemed at the investor's request during the term of the Fund. The recommended holding period has been determined taking into account the remaining duration of the Fund, linked to the duration of the Master Fund, excluding any possible extensions of its term. No redemption fees apply at the end of the Fund's term.
